## **SHANGRI-LA DEBIT CARDTERMS & CONDITIONS**

Person having Personal account with **Shangri-la Development Bank Ltd.** (herein after referred to as the "Bank") may avail ATM facility from the Automatic Teller Machine (herein after referred to as "ATM") in branches and/or any ATM counters under SCT network where ATM are installed by using Shangri-la Debit Card (herein after referred to as "CARD") subject to the following terms and conditions.

- 1. The Debit Card and the Personal Identification Number (herein after referred as "PIN") slips shall be issued to the Account Holder (Card Holder) at his/her sole risk and responsibility.
- 2. The card is not transferable and shall be used exclusively by the Card Holder. The Card Holder undertakes to destroy the PIN slip after memorizing the PIN Number.
- 3. If the information submitted by Cardholder is found to be false and/or the Card has been misused, the Bank reserves the right to seize/cancel the Card issued to any Cardholder.
- 4. The Bank reserves the right to terminate membership, withdraw the privileges attached to the Card or not renew the expired Card at anytime and to call upon the Cardholders to surrender the Card.
- 5. Use of the Card after notice of withdrawal of the privileges of the termination of the membership is fraudulent and may be subject to legal action by the Bank in accordance with the prevailing law.
- 6. Upon termination of membership or withdrawal of privileges of the Card for any reason or whatsoever, the card shall be returned to the concerned branch within 7 days from the date of receipt of notice. The Cardholder shall be liable for payment of the bills arising out of use of the Card till Card is not surrendered to the Bank.
- 7. The Cardholder shall provide written instructions to the Bank for the cancellation/non-renewal of the Card one month prior to the expiry date specified in the Card.
- 8. The Card Holder is allowed to withdraw cash within the arranged limit and make payment for his/her purchase to the merchant through Point of Sale (herein after referred to as "POS") by using this card.
- 9. The Card Holder will be provided following facilities through ATM with the help of this card.
  - a) Cash Withdrawal

b) Fast Cash

c) Balance Enquiry

- d) PIN Change
- 10. The Card Holder undertakes to notify the Bank in writing of any loss, damage or theft of the card or disclosure of the PIN and hereby agrees to be liable for all the transactions made by the use of the card prior to the receipt of such written notice by the Bank.
- 11. The Bank shall debit the designated account of the Card Holder for all transactions initiated including cash withdrawal by using the card. For this purpose, the Card Holder irrevocably authorizes the Bank to debit his/her designated account affected through the use of his/her card.
- 12. In case of Joint Nominated Account(s), all the members shall be jointly and severally be responsible for all transactions performed on Card.
- 13. The Bank shall determine the minimum balance required to maintain in designated account of the Card Holder for the use of ATM facility of the Bank. The Card Holder agrees to pay applicable charge in case of withdrawal beyond such amount.
- 14. The Bank shall debit the designated account for all fees and charges as determined by the Bank relating to the Card and the services thereby provided.
- 15. The Bank reserves the rights to limit daily Transaction including cash withdrawal and purchase by the Cardholder and decide on denomination that would be dispensed from Bank's own ATM.
- 16. Wrong entry of PIN for three consecutive times while making cash withdrawal will automatically make the card in-operative. In such cases the Card Holder will have to contact the concerned authority of the Bank for making the card revalidated for operation.
- 17. Any mistake in the transaction slip has to be reported to the bank by the Card Holder immediately. The Card Holder further undertakes to accept full responsibility for all transactions made by the use of the card whether or not made with his/her knowledge or authority and he/she shall accept the bank's record of transactions as binding for all purposes.
- 18. The Card issued to the Card Holder shall remain, at all times, the property of the bank and shall be surrendered to the bank on demand. The bank at its sole discretion reserves the right, at any time, to cancel or withdraw the card or refuse to reissue, renew or replace the card without assigning any reason.
- 19. The Bank shall not be responsible in any way for non-availability of ATM services for any reason whatsoever and howsoever arising as a result of malfunctioning of the card or ATM, mechanical or power failure or otherwise.
- 20. It is Card Holder's responsibility to check the statement from time to time to confirm correctness of transactions.
- 21. Any dispute related with transaction performed through card must be notified to Bank within 30 days of transaction for processing change back.
- 22. The Card Holder undertakes to indemnify the Bank against all losses, damages, cost or expenses incurred and sustained by the Bank due to the Card Holder's failure to observe any of the terms and conditions herein mentioned. I have read understood and confirm my acceptance to above mentioned terms and conditions applicable to the issuance and use of Shangri-la Development Bank Ltd. Debit Card.
- 23. The Bank reserves the right to amend these terms and conditions along with fees and charges with or without prior notice to the Cardholder and such amendments shall be binding to the Cardholder.
